Being committed to the qualification of the juvenile justice's intervention, DGRS, is part of the European Programme PREVENTION OF AND FIGHT AGAINST CRIME, through the VALERE Project.

The VALERE Project began in 2007, and the thematic areas under its analysis have been collecting information that allows evaluating the need of improvement both on young offender's assessment, as well as their social reintegration needs, in order to achieve the qualification of the proper answers towards their behavioural change and recidivism prevention.
